Ohio retirement law prohibits the release of confidential account information to a third party unless written authorization is provided by the member or retiree. You or the third party must contact OPERS separately to request account information. This form cannot be used to initiate a request for information. This form will not authorize the release of Protected Health Information (PHI) (re: a retiree or dependent's health care coverage). If you wish to authorize the release of PHI, please contact OPERS to request the HIPAA Authorization Form.
